

Ashaisam-2008/Pro.No.133/2008/Ka.1. I am satisfied that 👒 it is being established and operated by persons belonging to the linguistic (Sindhi) minority or with the grant of an individual as declared by the Third State Commission prescribed vide July 4, 2008. Result: The said institution is hereby declared to be a linguistic (Sindhi) minority educational institution

This certificate will be applicable only for the state of Maharashtra. The linguistic minority status granted to the said institution shall be applicable to all academic branches operated by the institution.

The Linguistic Minority Status hereby granted to the above mentioned educational institution shall be valid from the academic year 2008-09. The concerned body has issued the Minority Development Department, Government Decision, no. It will be mandatory to consistently and specifically fulfill the criteria and conditions prescribed under ASHAIS-2008/P.No.133/2008/Ka.1, dated 4th July, 2008.
