**PREAMBLE TO IUIN-DRR MEMORANDUM OF ASSOCIATION**

Despite continued efforts in reducing disaster risk, economic losses from disasters are rising globally. It is estimated that it has increased from US\$50 billion each year in the 1980s, to just under \$200 billion each year in the last decade (World Bank and GFDRR 2013). India is also experiencing a similar trend with an average annual estimated economic loss of \$9.8 billion out of

which more than \$7 billion is due to floods (GAR 2015<sup>1</sup>) which is a recurring phenomenon in most of the states in the country. One of the key drivers behind such increasing economic loss due to disasters is lack of knowledge about hazards and access to risk information, which is essential to undertake any risk reduction action. Also there is a continuous accumulation of newer risks due to increasing exposure to hazards resulting from risk insensitive planning mechanism, ecosystem degradation, population growth and poverty. The risks induced by climate change are adding a further new dimension to the existing disaster risk profile of India.

Although there is uncertainty regarding the impacts of climate change, change in average climate conditions and variability are visible, and extreme climate events are being experienced annually in recent past resulting in huge economic loss and devastation. The growing economy in India also results in high investment for infrastructure development, industries and other revenue generating sectors and businesses. Rarely these investment decisions take hazard exposure into account thereby increasing the exposure of economic assets to various kinds of natural and human induced hazards.

Building on the **Hyogo Framework for Action**<sup>2</sup>, which featured ‘knowledge, innovation and education to build a culture of safety and resilience as a key priority, the **Sendai Framework for Disaster Risk Reduction 2015-2030**<sup>3</sup> identifies “Understanding Disaster Risk” as its first Priority for Action. Enhancing awareness including through formal and non-formal education, research, civic and professional education and training at all levels have been identified as some critical means to achieve this.

### **The Sendai Framework: Priorities for Action**

**Priority1. Understanding disaster risk:** Disaster risk management should be based on an understanding of disaster risk in all its dimensions of vulnerability, capacity, exposure of persons and assets, hazard characteristics

and the environment. Such knowledge can be used for risk assessment, prevention, mitigation, preparedness and response.

**Priority2. Strengthening disaster risk governance to manage disaster risk:** Disaster risk governance at the national, regional and global levels is very important for prevention, mitigation, preparedness, response, recovery, and rehabilitation. It fosters collaboration and partnership.

**Priority3. Investing in disaster risk reduction for resilience:** Public and private investment in disaster risk prevention and reduction through structural and non-structural measures are essential to enhance the economic, social, health and cultural resilience of persons, communities, countries and their assets, as well as the environment.

**Priority4. Enhancing disaster preparedness for effective response and to “Build Back Better” in recovery, rehabilitation and reconstruction:** The growth of disaster risk means there is a need to strengthen disaster preparedness for response, take action in anticipation of events, and ensure capacities are in place for effective response and recovery at all levels. The recovery, rehabilitation and reconstruction phase is a critical opportunity to build back better, including through integrating disaster risk reduction into development measures.

The **Disaster Management Act of India 2005** and the **National Disaster Management Policy (2009)** also articulate the need to conduct detailed hazard risk and vulnerability analysis for preparation of effective disaster management plans at various levels. Importantly, the **National Disaster Management Plan (2016)**, one of the first national DRR plans globally to be aligned with the Sendai Framework, highlights the vital role of education and the integration of DRR into curricula at various levels, besides outlining the role of universities as technical resource centres.

The **2018 Asian Ministerial Conference on Disaster Risk Reduction**<sup>4</sup> in Ulaanbaatar reiterated the need to incorporate disaster risk reduction education

at primary, secondary and tertiary levels and professional training. Partnering with Higher Education Institutions (HEI), universities and other science and technology communities have been envisioned for promoting innovative technology and research, facilitate capacity development, and contribute to decision-making for addressing local risks and the needs of the most vulnerable. Honourable Prime Minister of India has given 10 point agenda on disaster management.

1. All development sectors must imbibe the principles of disaster risk management.
2. Work towards risk coverage for all-starting from poor households to SMEs to multi-national corporations to nation states.
3. Encourage greater involvement and leadership of women in disaster risk management.
4. Invest in risk mapping globally. For mapping risks related to hazards like earthquakes we have accepted standards and parameters.
5. Leverage technology to enhance the efficiency of our disaster risk management efforts.
6. Develop a network of universities to work on disaster issues.
7. Utilise the opportunities provided by social media and mobile technologies.
8. Build on local capacity and initiative.
9. Opportunity to learn from a disaster must not be wasted. After every disaster there are papers on lessons that are rarely applied.
10. Bring about greater cohesion in international response to disasters.

In order to address capacity, skill and knowledge gap, the Agenda 6 stresses on the need to “*Develop a network of universities to work on disaster issues in India*”. Furthermore, the Agenda 6 envisions enhancing global & regional level actions under Priority 1 (d) in order “*To promote common efforts in partnership with the scientific and technological community, academia and*

*the private sector to establish, disseminate and share good practices internationally”.*

To address this, **India University and Institute Network for Disaster Risk reduction (IUIN-DRR)** is established with several esteemed universities in India, which come together to share knowledge resources related to disaster risk management amongst themselves and beyond to the larger group of stakeholders working on DRR.

IUIN-DRR members work in close collaboration to conduct education and research, share findings and find ways forward in a country that is increasingly at threat due to climate change impacts and disaster risks. The university members work closely with governments, international agencies and corporate and civil society organizations to establish collaborations that eventually lead to resilient communities and robust policies towards this goal. IUIN-DRR reflects each member’s commitment to implementation-oriented education and research in the field of disaster risk reduction.

This document is the operational framework of IUIN-DRR, which is discussed by the focal persons of member universities, and does not entail any legal obligations to its member universities.

### **MEMORANDUM OF ASSOCIATION**

- For first two years of MOA, network will be considered in incubation period (in the process of setting up) therefore, the proposed organization structure will be flexible and ED, NIDM will be Executive Head.
- ED, NIDM would be Chairperson of this network with final authority over all matters pertaining to the Network.
- Initial Funding would be taken care of by NIDM/ MHA/ UNISDR subject to approval of the competent authority.

- The Network will run as part of NIDM project.
- Version 2 of MOA would be drafted at later stage based on the two year experience of its implementation.

### **PART A: India University and Institute Network for Disaster Risk Reduction**

#### **Article 1. Name, Vision**

##### **1.1 Name**

**India University and Institute Network for Disaster Risk reduction (IUN-DRR)** is a network of universities and institutions undertaking education and research in the fields related to disaster risk reduction.

IUN-DRR is non-partisan and operates without discrimination in regard to race, gender, political or religious conviction and social and economic background.

##### **1.2 Vision**

Vision of the IUN-DRR is to build nation and communities safe and resilient to disasters, through education, knowledge creation, research, technology and dissemination.

#### **Article 2. Objectives**

1. To enhance recognition of the vital role of universities in implementation-oriented education and research in disaster risk reduction and related field
2. To provide a platform for interface between academia and policy across the country in different states.
3. To enhance the growth of young professionals and practitioners in disaster risk reduction

4. To document, develop and disseminate knowledge products in the field of disaster risk reduction
5. To share and work together (bilaterally or multilaterally) in promoting disaster risk reduction in higher education (focusing on, but not restricted to, post-graduate education)
6. To collaborate on field-based and policy oriented research focusing on different aspects of disaster risk reduction and related fields
7. To broaden the scope of education and learning in disaster risk reduction field through collaboration with diverse stakeholders including NGOs, private sectors, media and local governments
8. To provide a forum for consultation, information sharing and cooperation among universities on matters and themes of common interest

### **Article 3. Activities**

The activities of IUIN-DRR are:

1. To promote effective partnerships among universities across the country, in specific, and all regions of the world, in general, through education, research, dialogue, forum, project implementation, conferences and publications
2. To generate, collect, coordinate and disseminate information to people, governments, intergovernmental and non-government organizations and international and bilateral agencies
3. To facilitate and coordinate national and international advocacy on issues of major concern to IUN-DRR and its member organizations
4. To facilitate the establishment and strengthening of national professional councils and societies or other groupings of universities and research organizations with views similar to that of IUN-DRR
5. To maintain liaison with the national, state and local level designated body engaged in DRR



6. To organize meetings, forums and conferences to meet the objectives of the network

### **Article 4. Resources**

- IUIN-DRR shall obtain the funds and /or other forms of support necessary for its work through contributions, donations, grants, provided that these are not subject to conditions which are contrary to the vision and objectives of the network.
- All financial auditing will be done by the auditor appointed by NIDM.
- UNISDR's or other donors/ funder's role and their funding support should be clearly defined by Executive Committee/ NIDM/ MHA.
- The Secretarial support will be provided by NIDM.

### **Article 5. Structure**

IUIN-DRR shall have the following structure:

1. An Executive Committee will have a maximum of 15 members. It will be headed by ED, NIDM. One Faculty member from NIDM will be part of this committee. Other members will include one each of sufficient seniority from UGC, AICTE and AIU. The remaining two to four members of high credentials and established professionals and academia will be nominated/ invited. The Committee will also have one member each, from amongst the members of the Network, representing 5 different regions of the country.
2. General body of Member Universities/ Institutions (hereinafter referred to as General Assembly).
3. Other need-based committees, bodies and initiatives to be decided by the Executive Committee.
4. Coordinating NIDM Faculty would be Member Secretary of this network.
5. NIDM will house the secretariat which will be supported by consultant and secretariat staff.

## Article 6. Membership

### 6.1 Membership

The following organizations can be members of the IUN-DRR:

- National and International Universities / institutes conducting education/research and extension programs in disaster risk reduction and climate change.
- Individual- (to be opened at later stage)
- The membership will be initially open to selected/ select organizations as determined by the Executive Committee.
- Universities/ Institutions engaged in disaster risk reduction and climate change activities based on the criteria to be decided separately.
- Member universities retain their autonomy, including the right of withdrawal from the network. The Executive Committee shall decide the membership of the network. Each member university needs to submit a signed membership note with a validity of three years, along with the name of the focal person for the network. The Executive Committee can invite universities to become members.

### 6.2 New Membership

A university seeking membership of IUN-DRR shall submit its request letter to the NIDM/ Executive Committee, IUN-DRR Secretariat with information on its activities related to the network objectives. The Executive Committee will decide on the inclusion of new members.

### 6.3 Observers

1. A university or research organization that wishes to participate in, or benefit from, IUN-DRR activities, but because of constitutional constraints or reasons of principles cannot be a member, may apply for an Observer Status. The Executive Committee shall decide on the

application based on a recommendation from the NIDM/ Executive Committee.

2. Governments, intergovernmental organizations, UN, civil societies, NGO networks and other official bodies similarly interested may be invited by the Secretariat to send official observers to the General Assembly after due deliberation by the Executive Committee.

### **6.4 Membership Fees**

At present, there is no membership fee. Fees, if any, will be reviewed at later stage (after one year).

### **6.5 Termination of Membership**

The membership of a university/ institute may be suspended for good and sufficient reasons by a decision of Executive committee.

## **Part B. IUN-DRR General Assembly**

### **Article 7. Functions of the General Assembly**

The General body is the supreme body of IUN-DRR with responsibility for formulation and review of policy and programs and report on their network related initiatives. Its functions are:

1. To discuss issues and concerns of the universities in education and research on disaster risk reduction across member universities;
2. To establish and review guidelines;
3. To review past programs;
4. To suggest, adopt future programs through presentation of proposals;
5. To receive and review reports from the Executive Committee;
6. To inform, through a brief report to the Secretariat, all the network-related and proposed activities at the beginning and end of each financial/ calendar year;

7. To receive audited financial statements, as and when applicable;
8. To consider such resolutions as may be submitted by member universities;
9. To establish and mandate working groups and other ad-hoc and standing bodies;
10. To review membership and contributions/ participation of members periodically.

### **PART C. Other Structures**

#### **Article 8. Composition of the Executive Committee**

1. An Executive Committee will have a maximum of 15 members. It will be headed by ED, NIDM. One Faculty member and Secretary (Programme Director) of the Secretariat from NIDM will be part of this committee. Other members will include one each of sufficient seniority from UGC, AICTE and AIU. The remaining two to three members of high credentials and established professionals and academia will be nominated/ invited. The Committee will also have one member each, from amongst the members of the Network, representing 6 different regions of the country.
2. Members of the Executive Committee shall serve for a maximum period of two consecutive terms, each term consists of 2 years. Every two years not more than one-third of the members of the Committee could change so as to ensure continuity.
3. The Executive Committee shall meet at least once in every quarter, which may be held face to face or through appropriate communication media.
4. The Executive Committee is free to co-opt members and also may utilize the services of specialists and advisors and may participate in an advisory capacity in the meetings of the Executive Committee, without vote.
5. In the event that a member university elected to the Executive Committee by the General body decides not to serve on it, or subsequently resigns, the

Executive Committee has the power to co-opt an additional member university/ Institute to fill such vacancy.

### **Article 9. Functions of the Executive Committee**

The Executive Committee is the policy, oversight and coordinating body on behalf of the General Assembly and other bodies mentioned in these Memorandum of Association. Its functions are:

1. To establish any necessary by-laws in accordance with the Memorandum of Association;
2. To raise funds and resources for the functioning of IUIN-DRR.
3. To pass upon applications, memberships to IUIN-DRR;
4. As and when required, to determine an annual budget and exercise control thereof, as well as to receive contributions, donations and legacies, and raise funds from such sources as it deems appropriate;
5. As and when required, to establish a committee on finance and administration to review all matters pertaining to financial resources, financial management and administration;
6. To establish terms of reference, composition and time limits for any other necessary committees, working groups or task forces;
7. To suspend or terminate agencies from membership for other good and sufficient reason, as established by the Executive Committee;
8. To apply for consultative or other status, as appropriate, with intergovernmental organizations and bodies;
9. To maintain relations with national or international bodies, groups or councils of voluntary agencies;
10. To prepare the meetings of the General Assembly, including the establishment of a nominations committee for the purpose of preparing the election by the General Assembly of the Executive Committee (Valid for version 2);
11. To formulate and implement policy in line with the general guidelines adopted by the General Assembly.

### **Article 10. Functions of the Secretariat**

The Secretariat will be housed at NIDM and supported by NIDM. The Secretariat works under the direction of the Executive Committee. It is led and managed by the Secretary, who is directly responsible to the Executive Committee.

The roles and responsibilities of the Secretariat are:

1. To work with the Executive Committee and member agencies to achieve the purposes of the network.
2. To facilitate organizing the General Assembly.
3. To facilitate the formulation of and implement with the authorization of the Executive Committee, policies, programmes and priorities identified by the General Assembly, the Executive Committee and other IUIN-DRR bodies, where appropriate.
4. To help define issues and recommend priorities in consultation with the membership on concerns that may warrant the attention/action of network's constituent bodies;
5. To propose specific activities to the Executive Committee;
6. As and when applicable, to manage the programs and finance of the network and report regularly to the Committee on Finance and Administration and Executive Committee;
7. To liaise and, when authorized by the Executive Committee, represent the Council with relevant governmental, intergovernmental and non-governmental organizations as appropriate in achieving network goals;
8. To facilitate and service the constituent IUIN-DRR bodies and other network meetings;
9. To provide services to members and other organizations as authorized by the Executive Committee;
10. To develop publications and outreach materials with its member universities;

- 11.To host the website and update the information contained therein; and
- 12.To promote membership of the network

### **PART D. GENERAL**

#### **Article 11. Language**

The working language of IUIN-DRR shall be English.

#### **Article 12. Amendments of Statutes (No voting for first two years)**

The Statutes may be amended in accordance with the following procedure:

1. A proposal for amendment may be submitted in writing to the Secretariat, either by a member of IUIN-DRR or by the Executive Committee, not later than thirty days prior to the opening of any meeting of the General Assembly. General Assembly will be announced with at least 60 days prior notice.
2. Any such proposal shall be submitted in writing to all IUIN-DRR members at least thirty days prior to the General Assembly;
3. Proposed amendments shall be accepted upon its adoption by the members present and voting;
4. Amendments so adopted enter into effect at the close of that General Assembly.

#### **Article 13. Review**

The performance of network will be reviewed after two year and accordingly version 2 would be submitted to the MHA and General Assembly.

All intellectual property solely conceived and/or developed by "**Dada Ramchand Bakhru Sindhu Mahavidyalaya, Nagpur**" during the course of this Agreement shall be owned by them. Intellectual property jointly conceived and/or developed by "**Anand Niketan College Anandwan, Warora**" and "**Dada Ramchand Bakhru Sindhu Mahavidyalaya, Nagpur**" will be jointly owned by **Anand Niketan College Anandwan, Warora** and "**Dada Ramchand Bakhru Sindhu Mahavidyalaya, Nagpur**". "**Anand Niketan College Anandwan, Warora**" and "**Dada**

Ramchand Bakhru Sindhu Mahavidyalaya, Nagpur" agree to collaborate towards the protection, if application of such intellectual property for commercial or other purposes on mutually acceptable terms with equal shares.

**Article- 7 FUNDING AND FINANCE:**







## Article 12: SETTLEMENT OF DISPUTES:



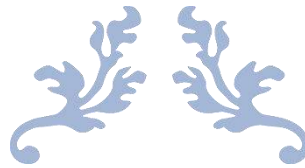
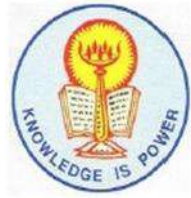

In case of any unresolved dispute, the parties shall refer the said dispute for arbitration by the sole arbitrator appointed by **HORIBA India Pvt. The provisions of Arbitration and Conciliation Act 1996 shall apply to such arbitration proceeding which shall be held at New Delhi.

**16. Jurisdiction**







Smt. Ushaben Chandrakant Thakar Women's College, Queta Colony, Nagpur, established by Shri Nagpur Gujarati Mandal, affiliated to Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur and approved by Govt. of Maharashtra, of the SECOND PART for the purpose of exchange of faculty members & students.

#### **PREAMBLE**

WHEREAS, Dada Ramchand Bakhru Sindhu Mahavidyalaya, Nagpur and Smt. Ushaben Chandrakant Thakar Women's College, Nagpur have many areas of common interest in Commerce, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of core academics, holistic education and research.

NOW THEREFORE, Dada Ramchand Bakhru Sindhu Mahavidyalaya and Smt. Ushaben Chandrakant Thakar Women's College have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

#### **ARTICLE 1: OBJECTIVE**

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality.

The two institutions shall seek to promote:

a. Faculty/Staff Exchanges

1. The exchange of faculty to the mutual benefit of both institutions,
2. Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest,
3. The exchange of academic materials and publications,
4. Conducting lectures,
5. Attachment of staff for purposes of curriculum development upgrading of teaching and research skills,
6. Participating in seminars, symposiums, and other types of academic discussions,
7. Co-supervising post-graduate students,
8. Conducting study tours and joint consultancy work.

A specific plan will be worked out for each activity; setting for the detailed arrangements for collaboration will be agreed. There will no extra remuneration for faculties for each visit or an assignment or such exchange.

b. Student Exchange

Dada Ramchand Bakhru Sindhu Mahavidyalaya, Nagpur and Smt. Ushaben Chandrakant Thakar Women's College agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme of study or research.

1. Exchange students will be selected by mutual agreement between the home institution and the host institution.

2. An exchange student will continue to be treated as full-time student at his/her home institution.

3. His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic advisor identified by the host institution.

4. The host institution will evaluate an exchange student's performance in each course or module, award a letter grade or marks, and issue a letter to that effect.

5. To avail travel facility, students can apply travelling assistance at their respective home institution.

6. The exchange students will not pay any kind of fees to their home institution.

c. Other Areas:

1. To conceptualization of NEP2020's holistic approach apart from core academic, sports activities focusing development sports attitude as well as proficiency would be initiated & promoted

2. To exchange information on research and educational programs,

3. To exchange information on teaching, learning material and other literature relevant to their educational and research programs,

4. To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein,

5. To organize jointly seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein,

6. To propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's faculty to participate therein,
7. To undertake joint students placement drives & skill training program.

**ARTICLE 2: COORDINATION**

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from both institutions will periodically review and identify ways to strengthen cooperation between the two institutions.

**ARTICLE 3: VALIDITY**

The Memorandum shall remain in force for a period of THREE years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

**ARTICLE 4: TERMINATION**

Either institution may terminate the MoU by giving written notice of one month in advance to the other institution.

The players from both the colleges will practice together and will be benefited, as our college students will use their play field and their college students will gain knowledge from the qualified coaches.

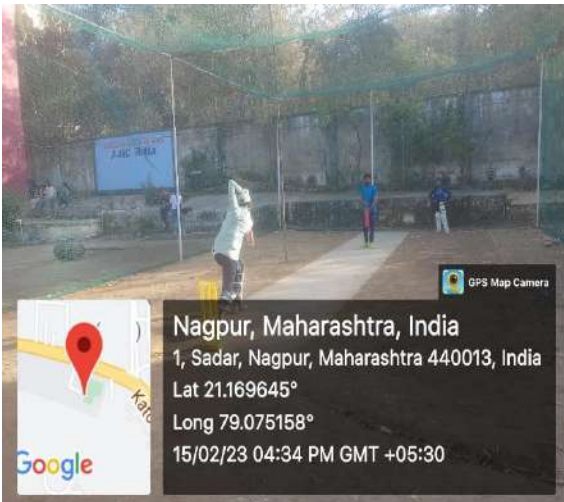
